## Need more money?

Get your taxes done for FREE and claim your Earned Income Tax Credit (EITC)

Working families with annual incomes under \$53,267 may qualify to get up to \$6,100 as a credit or refund on their 2014 taxes. It's called EITC or the Earned Income Tax Credit.

You can get EITC even if you don't owe taxes. But you must file a tax return to claim the benefits you earned.

## File your own taxes online for FREE at www.MyFreeTaxes.com

if you earn \$60,000 or less. It has helpful tools such as calculators, error checkers and online chats, plus a free help line if you have any questions (English/Spanish).
