**The FoodBank offers FREE personalized tax preparation** by certified tax professionals for households earning \$54,000 or less, at sites throughout Monmouth and Ocean Counties.

Working families in NJ with annual incomes under \$53,267 may qualify to get up to **\$8,114 as a credit or refund** on their 2015 taxes. It's called EITC or the Earned Income Tax Credit. **You can get EITC even if you don't owe taxes.** But you must file a tax return to claim the benefits you earned. You can file for free.

- **Monmouth Mall**, outside Boscov's 2nd floor, Until 4/15/16: Tues., Wed, Thu, Fri. 1-7pm, Sat 10-3pm. **Also Saturday April 16th** from 10 - 3pm and **Monday April 18th** from 1 - 7pm
- **Freehold Raceway Mall**, at the Financial Success Center of the Meridian Community Resource Center, (outside Macy's, first floor) Until 4/15/16 - Tues, Wed, Thurs 1-7pm, Sat 10-3pm, and **Also Saturday April 16** from 10 - 3pm and **Monday April 18** from 1 - 7pm

**What to Bring:**

- Valid driver's license or photo ID
- Previous year's return, if available
- Birth dates and social security cards (or verification letter) for yourself, spouse and dependents to be claimed on tax return
- Form 1095A if you received health insurance through the ACA Marketplace
- All income statements (W-2, Social Security, Unemployment or other benefits statements, self-employment records and any documents showing taxes withheld)

**Electronic Filing:** both spouses must be present to sign joint return

- Dependent child care information, if any
- Interest and dividend statements (1099B)
- Student loan interest payments, tuition, 1098T
- 1099R for pensions, annuities, social security benefits or RRB
- Copy of 2013 property tax bill, mortgage payments, 1098 with home mortgage interest, or rent receipts signed by the landlord
- Any other pertinent documents or papers.
